

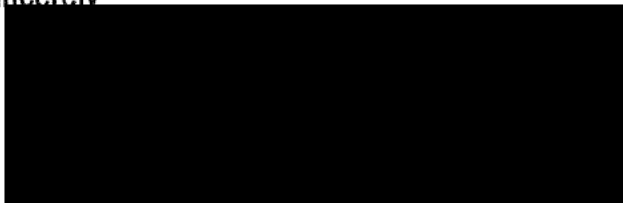

### WARRINGTON BOROUGH COUNCIL LOCAL PLAN SOUTH WEST URBAN EXTENSION FRAMEWORK PLAN

#### Importance and significance of the Green Belt Land
