The loss of 600 acres of greenbelt is not properly justified. Not only will this reduce the greenbelt by 11% but that loss is focussed almost entirely on the south Warrington area. The plan has not taken the opportunity to develop more brownfield sites and has not fully assessed the ecological impact of the loss of greenbelt or the impact on the communities in south Warrington areas where the local charm of these areas will be irreversibly damaged if this plan goes ahead.

The plan is not substantially different to the previous plan and has not taken account of the huge negative feedback it received.

The loss of greenbelt land needs to be massively reduced and more evenly distributed instead of focussing on the south Warrington area.

Any loss of greenbelt needs to fully assess the ecological impact as well as the impact on the local residents. The current plan to create many thousands of additional houses plus the logistics site will create a huge increase in traffic onto existing roads with no clear plan to alleviate the additional congestion on already overloaded road networks in south Warrington, especially considering the severe bottlenecks to traffic and congestion caused by the swing bridges crossing the Manchester ship canal. This increase in traffic will further increase pollution and deteriorate the air quality in the area which is utterly unacceptable.

The plan to build a "garden suburb" on south Warrington's greenbelt to deliver 5000 new homes by 2017, with further significant additions in subsequent years is unachievable and will not satisfy the key need for affordable housing. South Warrington has historically been a more expensive housing area and with the plan only requiring developers to build a maximum of 30% affordable housing the plan will not satisfy the key housing need. Instead it will most likely create a new commuter belt with residents commuting into Warrington or further afield creating additional traffic and associated pollution.

The proposed logistics site will create jobs for people who cannot afford to live on the new garden suburb and will commute out from less expensive areas - creating yet more traffic load and pollution on the already overloaded road network in south Warrington. There is no provision for this additional traffic load in the plan.
