3.4 simply appears to state the the exceptional circumstances required to justify the release of Green Belt are met because that will allow the 'identified need' for development to proceed. I cannot see a clear statement of the exceptional circumstances that amount to anything other than urban sprawl. This is a natural consequence of a growth driven economic model and does not amount to exceptional. The plan appears to rely heavily on the outcomes of Green Belt development rather than fully justifying the necessity to reclassify Green Belt in the first place. I can see that there are obvious economic benefits to the proposals but what are the current existing 'exceptional circumstances' that will justify the very thing that Green Belt legislation was designed to prevent?
