£600K has been allocated to Shaw Street playing fields to develop a 4G pitch provision. Who will manage this resource moving forward under the local playing resource strategy. Would it not be more prudent to allocate some finances to update and expand the current provision at Culcheth High School which already has the infrastructure and Livewire management systems in place to better manage and develop a local facility?
