I have tried to reply to the consultation using the online form but its quite difficult to use that to express my thoughts and opposition to the plan.

In particular I oppose the plan to build on green belt land and the "garden suburb". The number of homes suggested will completely change the area and I fear the town will end up more like Manchester with many sprawling suburbs etc. I have chosen to live in Warrington instead of a city like Manchester for a reason and I fear your plan will change Warrington to feel more like a city then a town.

My husband and I currently enjoy being able to quickly reach countryside and fields either on foot or bike and I fear we will no longer be able to do this. I am currently pregnant and it is extremedy worrying to think about what the area will look like in the coming years as we bring up our child and I fear we will need to re locate away from the town to maintain rural surroundings.
