The plan is not justified. This is because there are insufficient infrastructure proposals to deal with the huge increase in traffic and the pollution it will cause by the building of so many houses and the construction of more industrial units. The crossing of the Manchester Ship Canal are insufficient to cope with current traffic let alone the volumes likely as a result of this proposed overdevelopment. There is no justification either for release of Green Belt land when brown field sites like Fiddler's Ferry will shortly become available. The desecration of south Warrington should these proposals go ahead will result in the permanent alteration of the area's character and the current amenities it provides.

The plan is undeliverable because there is no guarantee that sufficient people and businesses will want to move to this area. Neither is there any certainty that medical facilities and schools will be put in place to service the increased demand produced by the overdevelopment. The council's track record is poor as poor in providing these facilities as it is in putting appropriate road infrastructure in place in this part of the town.
