Huge number of houses/dwellings to be built. Council's estimated number of houses built per year is higher than the Government's suggested number.

Building on green belt which was set aside to be just that - green belt.

Planning ahead by 20 years is too far in the future.

Additional congestion and pollution. Driving through Grappenhall, Latchford, Stockton Heath and into Warrington is painful enough as it is - often gridlocked. Bottlenecks at canal bridges. Additional queueing when there is an accident on the M6 or M56. Several residential streets in Grappenhall are already used as cut-through routes by commuters, delivery vans and lorries between Knutsford Road and Chester Road, ignoring the 20mph speed limit; this will only get worse under the proposed plans.

The character of the area of south Warrington will be destroyed - the area is practically the ONLY green space in the borough and this will be largely wiped out. This will affect biodiversity and wildlife.

It's questionable whether the plans will offer additional employment for Warrington residents, given that the location would likely be attractive to those travelling from towns along the M56 or M6.

Details of the associated infrastructure of schools and shops have not been made clear.

Shouldn't Fiddler's Ferry be at least considered for part of this plan?
