I do find the local plan proposals to be sound. I am alarmed at the impact to the green belt which I feel is unnecessary given the amount of brown belt land available in the area and should be exhausted until green belt land is touched. The pollution levels which have recently been published are already amongst the very highest in the country and can see no way this plan outlines remedies to this particularly as the local landscape with the canal infrastructure makes road development hard. The proposed numbers of houses to be built are above governments suggested figures and almost double population growth estimates. In addition the infrastructure of the town is already at breaking point. There is only one high school in South Warrington and it is already at capacity. I live 2.7 miles from it and fear my children wouldn't get in. All the above reasons are credible and real. Therefore the local plan proposals are not sound.
