Having read the Local Plan (specifically the plans relating to the Garden Suburb and South West development) the justification of exceptional circumstances for release of Green Belt land is not sound and the impacts on existing residents in the area have been understated.

There has been no assessment made of the impact of the Local Plan on existing residents from increased traffic through already congested routes in the town. As an example a round trip from Appleton to the Post Office collections centre in Milner Street on a Saturday (a journey of less than 4 miles) often takes an hour to complete.

The proposed neighbourhood centres may meet some specific household requirements but the the people living there will still travel into Stockton Heath, Grappenhall, Latchford and the town centre for entertainment and larger household purchases.

There doesn't appear to be a plan in place to mitigate the impact of the 5,000 additional houses that will form the new Garden Suburb in terms of traffic flow, congestion and parking on the existing infrastructure. Assuming the average household in the north west has 1.16 cars, there will be around 6,000 additional cars in the area. The only way to move around Warrington is via bridges, the plan makes no reference to this fundamental issue and there is no suggestion that any more crossing points will be built.

There are no detailed plans for the new neighbourhood centres in the Local Plan, not even a suggestion of the land area set aside for this. It is not clear whether the intention is to create a parade of shops with a vets, doctors surgery and general store similar to Appleton (Dudlows Green Road) which would be used for one off 'emergency' purchases or visits or whether space has been allocated in the plan for development of a village centre where residents would want to spend leisure time with shops, bars, supermarkets thus alleviating rather than adding to the already congested situation in Stockton Heath and other areas.
