The official projected population increase in Warrington would need only 528 houses to be built in a year . The council proposal of 945 houses per year is not required. The release of green belt land for development can not be justified on the basis of the limited projected population growth. The plan horizon of 20 years is too far ahead to justify release of green belt land now as more brown field sites will become available over this timescale.

I have concerns that the developments will increase already congested roads around the Stockton Health Area particularly around the pinch points of the canal crossings. The resultant increase in traffic congestion will also reduce air quality in the area . The development will have a detrimental impact on the quality of the area as distinctive village communities will be merged into an urban sprawl .
