Loss of Greenbelt is contrary to national policy and is far from justified against the objectives of the plan. NPPF para 134. The proposed SW extension would erode the gap between the two towns undermining purpose (b) in particular, ie preventing neighbouring towns merging into one another, but also purposes (a), (c) & (d)

The size of the housing allocation should be reduced and the Green Belt Gap increased.  
A generous buffer should be provided along the ship canal to screen buildings from view and provide an acoustic barrier.

Employment allocations on wildlife and leisure sites are contrary to national policy and also contrary to other policies in the plan to protect green infrastructure, ecology and recreation. (DC3, 4 & 5)  
Loss of wildlife and leisure sites NPPF Para 180. Plans should allocate land with the least environmental or amenity value.

The impact on residential amenities in Moore & Promenade Park makes the plan none effective in delivering the economic, social & environmental objectives required by the national policy.  
Impacts on residential amenity NPPF Para 170, 184-5. Protection of historic environment.

The proposed SW urban extension would erode the gap between the two towns undermining Green Belt purpose (b) in particular but also undermining purposes (a) checking unrestricted sprawl, (c) safeguarding the countryside from encroachment and (d) preserving the setting and character of historic areas.

On the current plans the buffer between the SW extension and Moore village is no more than one small field.

NPPF Para 180.

Planning policies should identify and protect tranquil areas which have remained relatively undisturbed by noise and are prized for their recreational and amenity value for this reason.
