Thank you for notifying Trafford Council as a specific consultation body to the Warrington Local Plan, as an area that adjoins Warrington's local planning authority area. Trafford Council welcomes the opportunity to comment on the Proposed Submission Version Local Plan.

Having reviewed the documents, Trafford Council does not have any specific comments to make at this stage of the plan process in terms of the soundness of the plan, its legal compliance or the Duty to Co-operate process.

Trafford Council welcomes the opportunity to work with Warrington Borough Council to ensure the Warrington Local Plan is complementary to both the Greater Manchester Spatial Framework (GMSF) and the Trafford Local Plan.
