You are tasked with making sure that our town has the adequate resource and infrastructure to provide citizens with good health and employment opportunities. Unemployment is low in comparison to other areas and many jobs are filled by people living outside of Warrington. This begs the question why are we going to give up our precious green belt upon which we depend for the oxygen that's required for our good health!

Over 40,000 people each year are dying from pollution related illnesses. Warrington has been identified by the WHO as one of the worst polluted he country - so why are we considering huge logistics developments on our green belt land. This is despite one such recommended approval being rejected by council members. Nothing in these planning applications does anything to enhance or improve our health and wellbeing. We have vastly more important and challenging issues in Warrington with a poor hospital, a broken social care system and severe lack of good quality recreational facilities. The council has invested in solar energy - but not in Warrington! with the council citing this as good use of tax payers money because of the income it returns (albeit over a hugely extended term). Why not invest in solar actually in Warrington?

The local plan states that only 10% of the greenbelt is being given up but that is 10% more than this town or this planet can sustain. The recent government statement about reducing emissions to zero is completely contrary to this councils position in the local plan - more housing, increased traffic and pollution and big industry occupying our green belt. The plan is not well thought through and will adversely affect the health of all of Warrington.

There is no strategy for improving rail, bus, cycling or wa kway options.

There is no credible strategy for the relief of existing congestion pinch points. Including Stockton Heath high street and swing bridge, Latchford/Kingsway as well.

The plans do not address how bus usage will increase when over the last 10 years this has fallen by around 50%.
