

THE BOROUGH OF WARRINGTON (COVID-19 RESPONSE) (WINWICK STREET) (BUS STAND, VARIOUS PROHIBITIONS/RESTRICTIONS & SUSPENSIONS) TEMPORARY ORDER 2020

WHEREAS the Warrington Borough Council (hereinafter referred to as “the Council”) is satisfied that the said roads should be restricted to facilitate COVID-19 response and recovery measures that will affect the highway:

NOW, THEREFORE, the Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following Order:

1. The Order specified in Column 1 of the Schedule to this Order is temporarily suspended to the extent as detailed in Column 2 of the said Schedule.
2. No person shall cause or permit any Motor Vehicle to wait at any time on the east side of Winwick Street from its junction with John Street for a distance of 5 metres in a southerly direction.
3. To introduce a Bus Stand on the east side of Winwick Street from a point 5 metres south of its junction with John Street for a distance of 32 metres in a southerly direction, operational Monday to Saturday between the hours of 7am and 7pm and a Sunday between the hours of 9am and 5pm, where no person shall cause or permit any Motor Vehicle to wait unless it is a bus.
4. No person shall cause or permit any Motor Vehicle to wait for a period of more than 30 minutes with no return within 1 hour, every day, between the hours of 8am and 6:30pm on the east side of Winwick Street from a point 37 metres south of its junction with John Street for a distance of 18 metres in a southerly direction.
5. No person shall cause or permit any Motor Vehicle to proceed in a westbound direction on John Street between its junction with Winwick Street and its junction with Ashton Street.
6. Nothing in Article 5 of this Order shall render it unlawful for any person to proceed along the said length of road on a Pedal Cycle.
7. This Order shall cease to have effect 18 months from the date of operation and supersedes any contravening orders.
8. This Order shall come into operation on the 7th day of July 2020 and may be cited as “The Borough of Warrington (Covid-19 Response) (Winwick Street) (Bus Stand, Various Prohibitions/Restrictions & Suspensions) Temporary Order 2020”.

The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation Order 2018	Is suspended in so far as it relates to the following: - <u>Schedule 3 – No Waiting at any time:</u> Winwick Street (East Side) - From its junction with John Street for a distance of 10 metres in a southerly direction. <u>Schedule 48 – Waiting limited to 30 minutes, every day 8:00am to 6:30pm, No return within 1 hour:</u> Winwick Street (East Side) - From a point 10 metres south of its junction with John Street for a distance of 45 metres in a southerly direction.
