What are our priorities for 2020-22?

The work of the partnership is driven by the voice of children and families

The partnership will support all agencies to work together to improve outcomes for children

The partnership will drive continual learning to improve practice in Warrington

The partnership will develop services and responses to needs identified

What are we planning to do to achieve this?

- Children and young people influence WSP functions through the creation of a Young Peoples board.
- Opportunity is given for children to co-design their page of the WSP website.
- Partner agencies share service user feedback to shape the strategic direction of the WSP.
- Develop links with community forums to consult on safeguarding issues, use feedback to assist WSP to respond to the safeguarding priorities.
- Develop links with community forums to promote the work of WSP.
- Feedback from children and families to be part of the quality assurance framework including contributing to the learning from case reviews and audits.

- Promote and improve understanding of professional challenge and escalation.
- Development of a Practitioners Forum that allows multi agency discussion and challenge which shapes strategic actions.
- Raise awareness of Safeguarding Children and the role of the partnership to children and adults workforce.
- Improve multi agency working across children's and adults services, through promotion of a “Think Family”, “Think Safeguarding” all age safeguarding approach.
- Promote the importance of timely information sharing. Data Protection Legislation and fears it must not be a barrier to sharing information

- Website development to include resources and guidance for practitioners including promotion of policy and procedures.
- Develop and manage a training programme that meets required standards and locally identified needs.
- Through the Quality Assurance Framework scrutinise and challenge performance; identify, disseminate and embed lessons and evaluate the impact on outcomes.
- Safeguarding partners should take account of the findings from their own local reviews and from all national reviews, with a view to considering how identified improvements should be implemented locally.
- A Training Quality Assurance process to be developed to address the relevance, currency and accuracy of course material and the quality of training.
- Write and implement a multi-agency agreed Training Strategy.

- Review and evaluate the success of the current Neglect Strategy. Continue with the WSP offer of Neglect / GCP2 training for all staff.
- Contribute to the review and evaluation of the Domestic Abuse Strategy and develop the future multi agency response for Domestic Abuse.
- Develop a clear understanding of the range and extent of child exploitation in Warrington.
- Embed clear lines of accountability for reporting with regards to child exploitation.

What will the outcome be?

- Families and children recognise the work of the WSP and how they have contributed to it.
- The views of community are heard and considered when developing safeguarding practice.
- A wider engagement with children and young people will lead to a better understanding of missed opportunities, good practice and awareness of their needs, thus leading to improved practice across the agencies.
- Effective resources and improved knowledge for children about where they can source help and guidance.

- High quality partnership working is evidenced through audits and learning reviews.
- Evidence of professional challenge and escalation embedded within practice.
- The views of front-line practitioners informs front line strategic delivery.
- Improved communication and information-sharing between professionals, including a common understanding of key terms, definitions and thresholds for action.
- Professionals and volunteers working with children and young people recognise the work of the WSP and how they have contributed to it.
- Universal and specialist services identify children and adults in need and in need of protection through increased understanding of the impact of all family members on each other.

- Increase in practitioner confidence and reduced incidences of cases where practice is judged inadequate or requiring improvement.
- Feedback from practitioners is that training is improving skills, knowledge and confidence and is impacting upon changes to their practice, improving outcomes for children.
- There is a shared understanding of the tasks, procedures, principles, roles and responsibilities outlined in national guidance and local arrangements for safeguarding and promoting the welfare of children.
- Practitioners respond effectively to children safeguarding needs.
- Partnership challenge and scrutiny function improves multi agency practice.
- Partners are working together effectively and achieving the best outcomes for children and young people in Warrington.

- Warrington will have a clear strategically driven, multi-agency response to children experiencing neglect, with well embedded, effective multi-agency strategy and assessment framework leading to a reduction in children and young people experiencing long standing neglect by families getting help earlier.
- Children identified at risk of child exploitation are identified at earliest point.
- Help is offered at the earliest opportunity, minimising long term impact of living with DA.
- Warrington's multi-agency workforce recognise the early and emerging signs of future risks for young people and respond with preventative interventions.
