THE BOROUGH OF WARRINGTON (TRAFFIC MANAGEMENT) (CIVIL ENFORCEMENT) CONSOLIDATION
(AMENDMENT NO.44) ORDER 2022

Notice is hereby given that the Council proposes to make an Order under Sections 1, 2, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers. The effect of the Order will be as follows: -

1. Revoke the Order detailed in Column 1 of the Schedule to this Notice to the extent as detailed in Column 2 of the said Schedule.
2. The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation Order 2018, is hereby further varied or amended as follows:-
 - (a) In the 3rd Schedule by the **addition** of:-

NO WAITING AT ANY TIME

The Cross (unclassified) (North East Side) From its junction with A6144 The Cross in a southerly and easterly direction to a point 10 metres west of its junction with Pepper Street.
