Thank you for consulting Historic England on the above document.

Historic England is the Government's statutory adviser on all matters relating to the historic environment in England. We are a non-departmental public body established under the National Heritage Act 1983 and sponsored by the Department for Culture, Media and Sport (DCMS). We champion and protect England's historic places, providing expert advice to local planning authorities, developers, owners and communities to help ensure our historic environment is properly understood, enjoyed and cared for.

Historic England supports the content of the submission version of the Warrington Local Plan and the accompanying evidence base. Our response is attached to this letter.

The plan sets out a positive strategy for the conservation and enhancement of the historic environment as required by the NPPF (Paragraph 190). The plan includes strategic and development management policies which will sustain and enhance the significance of the Borough's heritage assets. In addition, the site allocations are accompanied (and referenced within each site policy), by robust historic impact assessments which demonstrate that the sites can be developed without harm to the historic environment.

Historic England has worked with Warrington Borough Council on an ongoing basis throughout the preparation of the Plan. We welcome the opportunities the Council provided at all stages of the Plan to comment and provide advice on the Plan's site allocations and policies. The Council's positive approach to the historic environment and their active engagement with Historic England, has resulted in a Plan which we support and, consider to be sound in terms of the requirements of the NPPF and the historic environment.
