THE BOROUGH OF WARRINGTON (TRAFFIC MANAGEMENT) (CIVIL ENFORCEMENT) CONSOLIDATION
(AMENDMENT NO. 55) ORDER 2023

Notice is hereby given that the Council proposes to make an Order under Sections 1, 2, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers. The effect of the Order will be as follows: -

1. The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation Order 2018, is hereby further varied or amended as follows:-

(a) In the 3rd Schedule by the deletion of:-

NO WAITING AT ANY TIME

Lodge Lane (East Side)	From its junction with Folly Lane for a distance of 60.5 metres in a northerly direction.
Lodge Lane (West Side)	From its junction with Lovely Lane for a distance of 18.4 metres in a northerly direction.
Lovely Lane (North West Side)	From its junction with Lodge Lane for a distance of 107 metres in a south westerly direction.

(b) In the 3rd Schedule by the addition of:-

NO WAITING AT ANY TIME

Boteler Avenue (Both Sides)	From a point approximately 41 metres south west of its junction of Gerrard Avenue/Warwick Avenue in a south westerly direction to and including its cul-de-sac end.
Lodge Lane (North East Side)	From its junction with Folly Lane for a distance of 67 metres in a north westerly direction.
Lodge Lane (South West Side)	From a point its junction with Lovely Lane for a distance of 39 metres in a north westerly direction.
Lovely Lane (North West side)	From its junction with Lodge Lane for a distance of 115 metres in a south westerly direction.

(c) In the 71st Schedule by the addition of: -

NO LOADING AND UNLOADING AT ANY TIME

Bewsey Road (North East Side)	From its junction with Folly Lane for a distance of 65 metres in a south easterly direction.
Bewsey Road (South West Side)	From its junction with Lovely Lane for a distance of 109 metres in a south easterly direction.
Folly Lane (North West Side)	From its junction with Lodge Lane for a distance of 92 metres in a north easterly direction.
Folly Lane (South East Side)	From its junction with Bewsey Road for a distance of 74 metres in a north easterly direction.
Lodge Lane (North East Side)	From its junction with Folly Lane for a distance of 67 metres in a north westerly direction.
Lodge Lane (South West Side)	From its junction with Lovely Lane for a distance of 39 metres in a north westerly direction.
Lovely Lane (North West Side)	From its junction with Lodge Lane for a distance of 90 metres in a south westerly direction.
Lovely Lane (South East Side)	From its junction with Bewsey Road for a distance 40 metres in a south westerly direction.

(d) In the 92nd Schedule by the addition of: -

BUS STOP CLEARWAYS

Folly Lane (North West Side)	From a point 92 metres north east of its junction with Lodge Lane for a distance of 25 metres.
Folly Lane (South East Side)	From a point 74 metres north east of its junction with Bewsey Road for a distance of 25 metres in a north easterly direction.
Lovely Lane (North West Side)	From a point 90 metres south west of its junction with Lodge Lane for a distance of 25 metres, in a south westerly direction.
Lovely Lane (South East Side)	From a point 40 metres south west of its junction with Bewsey Road for a distance of 21 metres, in a south westerly direction.
