The latest published statement says that systems of financial control are not in place. -Two councillors with pecuniary interests in a private business operating from the council-owned pool have frequently been involved in decisions about the pool, in breach of conflict of interest policy and of legislation. -At least 4 clerks have resigned, some citing bullying from current councillors. -Unspecified fees have been taken (twice) from the fairground operator at the community Carnival.
