Outstanding actions not covered elsewhere on agenda

The council submitted a bid to Innovate UK 'Net Zero Living Pioneering Places' fund to develop a mission focused net-zero method for local application drawing on innovation diffusion theory. The bid was unfortunately unsuccessful but the Net Zero Living Programme includes a fast follower competition, the details of which have now been released and the competition due to open soon

Communications Update

- Since the last meeting the Commission was represented at a faith climate event where a presentation was given on the new climate strategy
- Adverts were run to coincide with COP27 to promote the commission's social media accounts. These resulted in a doubling of Twitter followers and tripling on Facebook
- The intention is to progress a climate action website later in the year linking up with other local climate activity
- Work is ongoing to set up a dedicated mailing list to enable e-bulletins to be sent out to interested parties

Commission's Forward Plan

- ➤ A forward plan for the year had been drafted and was presented. This gives a simple overview setting out the main activities anticipated for the Commission plans over 2023 and the associated timescales
- A key activity is organising a public climate forum event
- > Discussion took place around engagement activities with the general public
- ➤ It was agreed to form a task group to bring communications interests together and develop the communications plan further
- It was suggested to cross-promote climate work with other messaging that is already being put out e.g. cost of living, transport initiatives etc.
- > Several opportunities for engagement were suggested by members of the commission including business event, annual property review and university event

➤ It was agreed to adopt the forward plan as a working plan taking on board the communications activities discussed

Local Nature Recovery Strategies (LNRS)

- Natural England presented on LNRS and the role of Natural England in their delivery
- The core purpose of LNRS is to help the reverse of the ongoing decline of biodiversity and nature
- ➤ LNRS aims to help restore and link up habitats so that species can thrive; the process will ensure local partners collaborate to agree the best places to help local nature recovery
- Natural England have a leading role in supporting responsible authorities to achieve the purpose, aims and process of LNRS
- There is huge crossover between the climate and ecological emergencies and Natural England hope to feedback activity on LNRS through this group

Net-Zero Review

- The Government's Net Zero Review which the Commission and the council both responded to last year has now been published
- The review picks up many of the points that were raised in the submissions made by the Commission and council
- It has re-emphasised the importance of net-zero for the economy and also highlighted the importance of local areas in delivering climate action

Council Updates

- ➤ The council have set up an internal task and finish group made up of representatives from each directorate. The group exists to develop a council climate action plan by the end of March
- A cyclops junction (cycle accessible cross roads) is expected to have works on site towards summer following consultation.
- The council's in-house carbon literacy training course is now up and running, with around 50 officers already completed or part-completed their e-learning
- ➤ The council have submitted 2 bids to the Public Sector Decarbonisation Scheme for the Town Hall and Walton Hall and are expecting to hear back imminently
