ID09 Schedule of Proposed Main Modifications 2023

Modification Reference Number MM002, Paragraph 3.2.23, etc.

I support the removal of the South East Warrington Employment Area (Six56 development site) as this reduces future urban development on existing Greenbelt land.

Modification Reference Number MM003, Paragraphs 4.1.24 to 4.1.33

I object to the reference that there may be more housing development beyond 2038/9 in the South East Warrington Urban Extension. There should be no more development on Greenbelt land.

Modification Reference Number MM020

I object to the huge amount of land to be removed from the Greenbelt in order to accomodate the South East Warrington Urban extension. The amount of land to be removed from the Greenbelt should be significantly reduced.

Modification Reference Number PMM05 Policy MD6, Page 7

I support the removal of the South East Warrington Employment Area (Six56 development site) from the map, keeping the land within the Greenbelt.
