# Why do you consider it is not sound (max 2000 words)

The proposed amendment is currently unsound as only part of the Manchester Airport Safeguarding Zone that is referred to in policy INF6 has been identified on the amended Policies Map. The updated Safeguarding Map for Manchester Airport, which MAG provided on 9th March, includes the following safeguarding consultation zones within Warrington:

- All buildings, structures, erections and works exceeding 90m in height
- All buildings, structures, erections and works exceeding 180m in height
- All buildings, structures, erections and works exceeding 360m in height

The amended Policies Map only shows the safeguarding zone in part of the east of the borough and therefore does not accurately reflect the full extent of Manchester Airport's Safeguarding Map across Warrington. All of the safeguarding zones that affect the borough should be shown on the Policies Map and the Main Modification must therefore be modified accordingly.

In addition to the above-mentioned safeguarding zones, the entire area of the borough is within the Manchester Airport safeguarding consultation zone for wind turbine development, which extends to a radius of 30km from the Airport. A note must therefore be added to the legend on the Policies Map to make this clear.




