ROAD TRAFFIC REGULATION ACT 1984

THE BOROUGH OF WARRINGTON (TRAFFIC MANAGEMENT) (CIVIL ENFORCEMENT) CONSOLIDATION
(AMENDMENT NO.54) (PART 2) ORDER 2023

Notice is hereby given that the Council made an Order under Sections 1, 2, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers on 16th August 2023. The effect of the Order is as follows: -

1. The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation Order 2018, is hereby further varied or amended as follows:-

(a) In the 3rd Schedule by the **deletion** of: -

NO WAITING AT ANY TIME

Richardson Street From its junction with Norris Street for a distance of 6 metres in a southerly direction.
(Both Sides)

(b) In the 3rd Schedule by the **addition** of: -

NO WAITING AT ANY TIME

Norris Street From its junction with Hallfields Road to its junction with Orford Avenue.
(North Side)

Norris Street From its junction with O’Leary Street for a distance of 42.5 metres in a south
(South Side) westerly direction.

Norris Street From a point 152 metres south west of its junction with O’Leary Street to its
(South Side) junction with Orford Avenue.

Orford Avenue From its junction with Norris Street for a distance of 12 metres in a north
(Both Sides) easterly direction.

Orford Avenue From a point 106 metres north east of its junction with Orford Lane for a
(North West Side) distance of 14 metres in a north easterly direction.

Orford Avenue From its junction with Orford Lane for a distance of 61 metres in a north
(North West Side) easterly direction.

Orford Avenue From a point 17 metres south west of its junction with Fitzherbert Street in a
(North West Side) north easterly direction to its junction with Norris Street.

Orford Avenue From its junction with Orford Lane to its junction with Roome Street.
(South East Side)

Orford Avenue From its junction with Richardson Street for a distance of 37 metres in a south
(South East Side) westerly direction.

Richardson Street From its junction with Norris Street for a distance of 11.5 metres in a south
(Both Sides) easterly direction.

Roome Street From its junction with Orford Avenue for a distance of 6 metres in an easterly
(South Side) direction.

(c) In the 92nd Schedule by the **addition** of: -

BUS STOP CLEARWAYS

Norris Street From a point 18 metres south west of its junction with O’Leary Street for a distance of
(South Side) 24.5 metres in a south westerly direction.

The Order will be effective from 11th September 2023 and maybe cited as “The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation (Amendment No. 54) (Part 2) Order 2023”

Any person who wishes to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any

requirement of that Act or any instrument made under it has not been complied with in relation to the Order may, within six weeks from 16th August 2023, apply to the High Court for this purpose.
