1 INTRODUCTION

1.1 Report Purpose

The purpose of this report is to document public engagement activities conducted in relation to potential traffic calming options on Gainsborough Road. The report outlines the consultation methodology, summarises the feedback received and outlines the next steps in the decision-making process.

1.2 Location

Gainsborough Road is located approximately 1 mile south of Warrington Town Centre, situated between Chester Road (A5060) to the west and Wilderspool Causeway (A49) to the east.

Gainsborough Road is predominantly residential, with approximately 160 properties, a small parade of shops at its centre, and offices at its eastern end (Wilderspool Park). It also serves several residential side roads.




Figure 1 – Gainsborough Road Location Plan

A location plan is provided in Figure 1 below:

1.3 The Issue

During the public consultation for Centre Park link road, concerns were raised by residents along and in the vicinity of Gainsborough Road about the impact of the new link road on traffic speeds, volumes, and routing in this area.

1.4 Previous Gainsborough Road Consultation - 2020

The Council held a public consultation regarding traffic calming options for Gainsborough Road in January and February 2020. Residents were invited to give feedback on the following options:

- Option A: Monitor and Review Undertake further traffic surveys in 2021, 6 months post opening of Centre Park Link to establish any change in vehicle speeds, volumes, and distribution prior to the implementation of any traffic calming measures. Further public consultation would take place after the monitoring period to share the results of the monitoring surveys and any proposed measures.
- **Option B: Permanent Chicanes** Implement chicanes along Gainsborough Road on a permanent basis.
- Option C: Temporary Chicanes Implement chicanes along Gainsborough Road as in Option B on a temporary basis with surveys undertaken to monitor their effectiveness. Further public consultation would be undertaken to present the results of the monitoring surveys and gain feedback on whether residents would like the traffic calming measures installed permanently.
- None of the above.
- I don't want traffic calming.

A summary of the results is provided below:

- 118 residents participated in the drop-in public consultation events.
- 106 respondents completed the consultation feedback form.
- The majority of respondents (46%) indicated they would prefer Option A, monitor and review followed by Option C (21%), temporary chicanes.
- When considering the option preferences of those residents that live on Gainsborough Road only, the preferred option was tied at 27% for Option A and 27% for Option B, permanent chicanes.
- The survey data was also analysed for respondents who live on Gainsborough Road and on the side roads served by Gainsborough Road. The preferred option selected by this group was Option A (41%) followed by Option C (24%), temporary chicanes.

Based on the survey responses, Option A monitor and review was recommended. This option stated further traffic surveys would be completed 6 months after the completion of Centre

Park Link followed by a further public consultation to present the survey results and traffic calming options based on the evidence collected.

1.5 Recent Public Consultation - 2023

Unfortunately, a further consultation could not be completed 6 months after the opening of Centre Park Link due to the COVID pandemic. Reliable traffic data could not be collected during this time. Therefore, once traffic levels had been seen to stabilise, a second public consultation was held in June and July 2023. The consultation sought feedback from residents regarding the implementation of traffic calming measures along Gainsborough Road. Residents were asked whether they would support the installation of traffic calming chicanes or alternatively would they prefer other transport-related improvements along Gainsborough Road.

Details of the options are provided below:




Figure 2 – Proposed location of chicanes

- **Traffic Calming in the form of six chicanes along Gainsborough Road.** A plan showing the proposed locations of chicanes and signage is provided in Figure 2. A larger scale plan is shown in Appendix A.
- Other transport related improvements. Instead of using the available funding for traffic calming chicanes, it could be allocated to other transportation improvements such as pedestrian crossings or bus stop enhancements.

2 METHODOLOGY

2.1 Methodology




Figure 3 - The OASIS model

The consultation process applied to this scheme is consistent with the Government Communication Service recommended OASIS model (Figure 3), which is routinely followed by Warrington Borough Council.

Each step shown in Figure 3 is discussed in sections 2.2 to 2.6 below.

2.2 Objectives

The objective of the consultation was to obtain feedback from residents on two potential approaches: one, to determine if residents want traffic calming measures along Gainsborough Road, and two, to identify other transport improvements they may be interested in.

- Implementation of traffic calming measures; or
- Implementation of any other transport improvements.

Residents were also given the option to state if they didn't know which measures should be implemented.

2.3 Audience Insight

The consultation aimed to reach the following target audiences:

- Residents living on Gainsborough Road
- Residents living in the vicinity of Gainsborough Road
- Local businesses
- Ward Councillors
- Local media

2.4 Strategy

The consultation strategy is built upon the need to ensure accurate, timely, and targeted communication through a variety of online and offline channels. Effective stakeholder engagement by the project team underpins this strategy.

The key messages of the consultation are as follows:

- Traffic calming options are being considered in response to concerns expressed by residents during the Centre Park Link consultation process.
- Resident feedback is crucial to inform the approach to the installation of any traffic calming measures or any other transport related improvements.
- A consultation report detailing the feedback received and the outcome of the consultation will be made publicly available.

2.5 Implementation

The consultation period took place between 22nd June 2023 and 24th July 2023. Table 1 outlines the implementation programme of this consultation activity.

2.5.1 Promotional leaflets

1300 copies of a promotional consultation leaflet were delivered to residents and businesses in the vicinity of Gainsborough Road. The leaflet provided information on the options, the purpose of the consultation, details regarding the timing and locations of public exhibition events, and instructions on how to provide feedback. The leaflets were delivered by an external distribution company, which conducted tracking operations to ensure that the leaflets were delivered correctly, as agreed upon.

A copy of the promotional leaflet is provided in Appendix B, and the distribution area is outlined in Appendix C. Additionally, copies of the leaflet were made available at the drop-in exhibition events for attendees to take with them.

2.5.2 Website

A dedicated project webpage was provided on the Council website at <u>https://www.warrington.gov.uk/consultations</u>. The webpage included information about the available options, a direct link to the feedback form, details regarding drop-in events, and contact information for reaching the project team. This ensured that those unable to attend the events could access the consultation materials online. A screenshot of the webpage is available in Appendix D.

A Council press release was also issued and can be found on the Council News webpage at <u>https://www.warrington.gov.uk/news</u>. A screenshot is provided in Appendix E.

Furthermore, residents had the option to raise consultation queries by emailing the Centre Park Link mailbox at <u>cpl@warrington.gov.uk</u>.

2.5.3 Public Exhibition Events

Two consultation events were held in July 2023 as shown in Table 2. The aim was to arrange times to maximise attendance for as many of the target audiences as possible.

The exhibitions featured seven display boards containing information about the options, as well as details on how to provide feedback to the project team. The display information can be found in Appendix G.

Council officers from the Transport Planning, Traffic Management, Road Safety, and Infrastructure Delivery teams staffed the events. Additionally, Ward Councillors were present at both events.

In total, the events attracted 73 attendees.

2.5.4 Promotion

In addition to promoting the events through leaflets and the project website, the exhibitions were also publicised through the following channels:

- Press releases were issued by the Council and made available on the Council News webpage (see Appendix E).
- Regular posts and tweets were shared on the Council's social media pages on Facebook and X (formally known as Twitter) (see Appendix H).
- Ward councillors received a consultation briefing note and briefing meetings in advance of the consultation, which included details of the proposed schemes and the consultation strategy.

2.6 Scoring/Evaluation

Feedback on the project proposals was gathered through various means:

- Online feedback questionnaires were made available on the Council's consultation page. The form consisted of thirteen questions, including three related to the project and ten mandated by the Equality Act, covering aspects such as age, gender, disability, and ethnic origin.
- Paper copies of the questionnaires were distributed at each exhibition and upon request for those without internet access. Approximately 30 paper copies were distributed at the two exhibition events, with 13 completed forms returned.
- Comments and inquiries were received through the Centre Park Link project mailbox.
- Consultations also took place through face-to-face conversations with members of the project team at the public exhibitions. Attendees were encouraged to complete a questionnaire.

A copy of the questionnaire is provided in Appendix I.

3 RESPONSES

Consultation feedback received is summarised in the sub-sections below.

3.1 Drop in events

The primary aim of the events was to inform attendees about their options, answer questions, and explain the feedback process. Attendees were encouraged to use the online or paper questionnaire to document their views.

Common questions posed to Council staff are documented in Table 3, along with responses provided by the project team staff on duty.

A summary of common themes of survey feedback and a corresponding action/response is provided in table 3 below.

Attendees were encouraged to complete the questionnaire to ensure that their views were documented.

3.2 Questionnaire responses




Figure 4 – All Respondent Locations


Figure 5 – Responses from residents of along and in the vicinity of Gainsborough Road.

There were 328 responses to the questionnaire, 28 of them from residents of Gainsborough Road. Figures 4 and 5 below provides an overview of the respondents' locations, including those along Gainsborough Road and its vicinity. Please note the blue circles represent a postcode group rather than specific addresses.

A summary of the responses to the project related questions are presented below.

Question 1 – Would you like traffic calming in the form of chicanes along Gainsborough Road?

All Respondents

The majority (83%) of all respondents chose 'No' (indicating that they do not want traffic calming in the form of chicanes along Gainsborough Road). Only 11% expressed a desire to see traffic calming measures implemented, and 6% were uncertain whether they wanted any traffic calming measures along Gainsborough Road. These results are shown graphically in Figure 6.





Figure 6: Feedback from all respondents on Traffic Calming measures on Gainsborough Road


Gainsborough Road Residents Only

When considering the preferences of those residents that live on Gainsborough Road, 54% (15) of participants said "No" for the traffic calming measures in the form of chicanes along Gainsborough Road and 46% (13) opted for "Yes" for traffic calming measures along Gainsborough Road. These results are shown graphically in Figure 7.

Note: Total number of properties on Gainsborough Road is approximately 160, meaning a response rate of less than 20% from properties on Gainsborough Road



Gainsborough Road & Side Roads Residents Only


Figure 8: Responses from residents of along and in the vicinity of Gainsborough Road.

When combining the Gainsborough Road respondents with those who live on the side roads off Gainsborough Road, 73% of participants don't want any traffic calming measures, 21% do and 6% of participants 'don't know'. These results are shown graphically in Figure 8.

Question 2 – As an alternative to traffic calming chicanes, the funding available could be used for other transport measures such as pedestrian crossings, bus stop improvements etc. What transport related improvements would you like to see along Gainsborough Road and where?

Out of 328 respondents, 276 comments were submitted in response to Question 2. The responses have been grouped into common themes. The most common comments and their proposed actions/responses are set out below.

The chart above illustrates the location of survey respondents, 9% live on Gainsborough Road, while 17% live on the side roads served by Gainsborough Road.

Equality and Diversity Questions

The feedback questionnaire contained ten questions required under the Equality Act on age, gender, disability, and ethnic origin. Anonymous responses to these questions are provided in Appendix J. The consultation was intended to primarily target residents and businesses on and within proximity to Gainsborough Road, no other demographic was targeted.

4.0 FURTHER INFORMATION

This section provides additional information regarding the optioneering process carried out during the development of the Centre Park Link for the junction format of Chester Road/Gainsborough Road.

4.1 Gainsborough Road/Chester Road Junction Optioneering

Several options were considered for the format of the junction of Chester Road/Gainsborough Road:

• **Signalisation** - The option was dismissed due to the close proximity of the Link Road, as determined by the new bridge's location, to Gainsborough Road. The immediate vicinity of Gainsborough Road and the Link Road would not provide sufficient stacking space for waiting vehicles traveling northbound on Chester Road, as there would be two adjacent signalised junctions.

During the public consultation for the Centre Park Link scheme, several respondents suggested the need for traffic lights at the Chester Road/Gainsborough Road junction. However, there were also respondents who believed that Gainsborough Road might be used as a shortcut to access the new bridge. One of the key factors influencing the latter possibility is the priority given to the right turn from Gainsborough Road to access the new link road if the junction is signalised.

- As existing with right turn ban out of Gainsborough Road The introduction of a rightturn ban at the junction of Gainsborough Road was dismissed partly due to the potential for Gainsborough Road traffic to use side roads as a through route, impacting overall access for local residents.
- As existing Traffic modelling indicates that this option can accommodate predicted traffic flows, providing full access out of Gainsborough Road while discouraging through traffic. As a result, this option was identified as the preferred choice.

4.2 Resurfacing of Gainsborough Road

Patch re-surfacing was undertaken on Gainsborough Road two years ago. The full resurfacing of the whole road by the council is now partly dependent upon the timing of the installation of a HyNet pipeline in the area. HyNet is a Government project to install hydrogen pipelines across the north west to decarbonise energy usage. The Council is awaiting timescales of when the infrastructure will be installed across Warrington before the programme can be set for resurfacing works.

5.0 SUMMARY AND NEXT STEPS

The Gainsborough Road traffic calming consultation period took place between 22nd June and 24th July 2023. Residents were asked whether they would support the installation of traffic calming chicanes or alternatively would they prefer other transport-related improvements along Gainsborough Road.

Details of the options are provided below:

- **Traffic Calming in the form of six chicanes along Gainsborough Road**. A plan showing the proposed locations of chicanes and signage is provided in Figure 2. A larger scale plan is shown in Appendix A; or
- Other transport related improvements. Instead of using the available funding for traffic calming chicanes, it could be allocated to other transportation improvements such as pedestrian crossings or bus stop enhancements.

The survey results show:

- The majority of respondents (83%) indicated that they were not in favour of the implementation of traffic calming measures in the form of chicanes, while only 11% of the participants were in support.
- When considering the option preferences of residents living on Gainsborough Road, only 13 of the participants were in favour of traffic calming measures in the form of chicanes along Gainsborough Road.
- Please note that 17 respondents, 5% did not provide their address and, therefore, cannot be included in the location analysis. However, they are accounted for within the overall analysis.
- Only 28 respondents (9%) live on Gainsborough Road.

Based on the survey responses, traffic calming in the form of chicanes will not be implemented due to the lack of majority support. However, the Council will undertake the following actions:

- Investigate the potential for crossing points along Gainsborough Road
- Continue to liaise with Cheshire Road Safety partnership regarding speeding concerns
- Undertake a study to assess the impacts of implementing traffic signals at the junction of Gainsborough Road/Chester Road following the settling of traffic flows post Covid.
- Consult with residents on the findings of the above.





The council has launched a public consultation, asking people to have their say on proposals to introduce chicanes – features designed to help manage the average speed of vehicles – on the road.

During the public consultation for Centre Park link, concerns were raised by residents along and in the vicinity of Gainsborough Road regarding the impact of the new link road on traffic speeds, volumes and routing in this area.

A public consultation was held in January 2020, which asked residents whether they wanted to see traffic calming installed.

Based on the results and the majority view, a decision was made to monitor the impact of Centre Park link once open and re-consult on the provision of traffic calming chicanes.

Although Centre Park link opened in March 2021, the COVID pandemic lockdowns meant that meaningful traffic data could not be collected until recently.

A comparison of pre and post Centre Park link traffic data along Gainsborough Road shows:

- an 8% reduction in traffic flows
- an increase in average speed of 2mph. from 28mph to 30mph

With regards to the impact of Centre Park link on the wider network, a 30% reduction in traffic flows has been observed on Chester Road and Wilson Patten Street.

Local people's feedback is now being requested on whether they would like traffic calming chicanes to be implemented along Gainsborough Road, or if they would prefer to see the available funding spent on other transport related measures, such as pedestrian crossing points and bus stop infrastructure.

You can get involved in the consultation by visiting warrington.gov.uk/consultations and completing the 'Gainsborough Road' survey.

There will also be two drop-in sessions at St Werburgh's Community Hub, Boswell Avenue, WA4 6DQ, where transport officers will be available to provide more information and answer questions.

- Wednesday 12 July 4pm-7pm

Paper copies of the survey will be available at these events.



This consultation is part of these ongoing discussions.

"Having begun these discussions in 2020, further consultation was delayed, in part by Covid and waiting for traffic flows to stabilise again.

"However, now that traffic levels have settled we are once again in a position to present the traffic data and get local people's views on potential traffic calming for the area.

Purpose of Consultation

Background

During the public consultation for Centre Park Link (CPL), concerns were raised by residents along and in the vicinity of Gainsborough Road regarding the impact of the new link road on traffic speeds, volumes and routing in this area.



Previous consultation

A public consultation was held in January 2020 which asked residents whether they wanted to see traffic calming installed.

Based on the results and the majority view, a decision was made to monitor the impact of CPL once open and re-consult on the provision of traffic calming chicanes.

CPL opened in March 2021. The COVID pandemic lockdowns meant that meaningful traffic data could not be collected until recently. Traffic flows have now settled with a new baseline of circa 95% of traffic levels pre covid in Warrington.

Current consultation

This consultation sets out recently collected traffic data to allow residents to make an informed decision on whether or not they would like traffic calming along Gainsborough Road or alternatively utilise the funding for other transport improvements.




Impact of CPL on the Wider Network

Centre Park Link opened in March 2021. Monitoring shows:

- A 30% reduction in traffic on Chester Road and Wilson Patten Street.
- A transfer of vehicles has occurred from Wilson Patten Street and Chester Road onto Centre Park Link (Slutchers Lane).
- A small reduction in general background traffic which is likely to be partially due to the effects of post-pandemic changes in behaviour such as increased home working.


Weekday Average Traffic Flows (2-way)





Impact of CPL on Gainsborough Road

A comparison of pre (2018) and post (2023) CPL data reveals:

- An 8% reduction in two way traffic flows
- A 1% reduction in the percentage of large 3 axle HGVs and above
- A 3% reduction in the percentage of smaller 2 axle rigid HGVs
- An increase in average speed of 2mph from 28mph to 30mph

Traffic Calming Option

Other traffic calming options considered

A number of alternative traffic calming Options were considered but not recommended:

- Vertical measures (speed humps/tables) Gainsborough Road is located on an old river bed with alluvium sub strata which would intensify noise and vibration from vertical measures.
- Speed cameras The decision to implement cameras is not within the control of the Council. Historic evidence of speeding and accidents is required by the police to implement.
- **Digital Vehicle Activated Speed Signs** Research shows that signs are effective for short periods of time and lose their effectiveness over time.
