

A PROPOSAL TO AMEND THE OFF STREET PARKING PLACES (CIVIL ENFORCEMENT) CONSOLIDATION ORDER TO ALLOW FOR THE ADDITION OF ORFORD JUBILEE NEIGHBOURHOOD HUB CAR PARK

STATEMENT OF REASONS

In March 2024 Orford Jubilee Neighbourhood Hub was transferred to Warrington Borough Council as part of a wider transfer of Neighbourhood Centre Hubs from Live Wire.

It was identified due to the popularity of the Hub and the requirement for continued parking enforcement that Warrington Borough Council continue with the existing parking conditions and enforcement that was enforced by a Private operator when operated by LiveWire.

It is proposed that existing parking conditions remain in place and there is a continuation of enforcement to deter motorists from breaching the existing terms and conditions of the car park.

The car park has a 3 hour limited stay for customers, which can be extended if customers provide their vehicle registration details via a terminal within the main building. This is to deter all-day parking for those who may wish to use the car park for purposes not associated with the services provided by the Hub.

Existing conditions such as parking within bay markings, not causing an obstruction, not parking in a disabled persons parking place unless displaying a valid blue badge would remain in place.

In order for enforcement of existing terms and conditions it is proposed that this car park is added to the current Off Street Parking Places Order.

A PROPOSAL TO AMEND THE OF STREET PARKING PLACES (CIVIL ENFORCEMENT) CONSOLIDATION ORDER TO ALLOW FOR THE ADDITION OF WALTON GOLF COURSE CAR PARK AND WALTON CREMITORIUM CAR PARK.

STATEMENT OF REASONS

Walton Hall car park operates as a public pay and display car park 7 days per week. It is accessed via Walton Lea Road and provides a parking facility for visitors to Walton Hall and Gardens.

There are 2 car parks located within close proximity to Walton Hall Pay and Display car park. These car parks provide parking for Walton Golf Course and Walton Crematorium. They are free to use permitting an unlimited duration of stay.

This allows for a minority of motorists to park free of charge on either Walton Golf Course or Walton Crematorium car parks whilst visiting Walton Hall Gardens without paying for a parking session.

To provide for a deterrent, whilst not penalising genuine visitors to both Walton Golf Course and Walton Crematorium, it is proposed for both car parks to be added to the current Off- Street Order with the following conditions:

Walton Hall Crematorium

It is proposed that Walton Crematorium car park is restricted to 1 hour maximum duration of stay with no return for 2 hours. Effective during weekends and Bank Holidays only, as these are the days when the majority of visitors to Walton Hall Gardens are parking on the Crematorium car park to avoid Parking charges. Parking would continue to be unlimited Monday to Friday.

Walton Golf Course

It is proposed that parking charges are introduced at the same levels as Walton Hall Gardens car park. If approved a Pay and display machine would be located in the car park and a pay and display ticket would be issued on purchase of parking time along with a voucher. The pay and display ticket would be clearly displayed on the dashboard or windscreen of the vehicle whilst the voucher would be taken into the Golf course reception where the parking charge may be refunded upon the purchasing of green fees.
